New Gym Floor

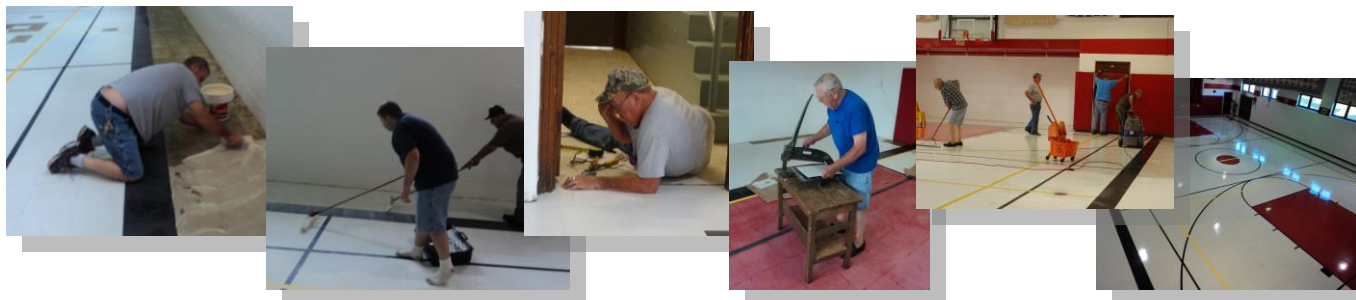

One of the biggest and most noticeable projects in recent memory has occurred at the Center this summer. Seven volunteers donated a total of over 150 hours of their time during July and early August on a major project to repair and improve the gym floor. The floor had deteriorated in recent years due to heavy use, with little time when not in use for maintenance stripping and waxing. Removal of bleachers had also exposed many areas of stained tiles around the perimeter of the gym.

Jerry Foster spearheaded the effort with members George Benz, Steve Dougan, Manuel Grueser, Dan Morhardt, Ralph Calvert, and Gail Jordan all helping a lot.

This gym floor project involved stripping wax, removing and replacing about 500 tiles, preparing the floor for finishing, masking and painting new yellow lines for volleyball, applying two clear coats of epoxy finish, and installing new base all around. Prior to beginning work on the floor itself, the lower side walls, which had been four shades of off-white, were painted white. So were the hallways to the seniors' room and to the cafeteria. The red padding on both ends of the gym was attached more securely. The fronts of the benches, which previously had been made from the former bleachers, were painted black, and nylon glides were installed so these benches will not mar the newly finished flooring.

Comments already have been numerous and very positive. The new epoxy finish is harder and more durable than wax, and the expectation is that with a little care the floor will continue to look good for a long time.

Oct. 7 - finish scarecrows & work on skeletons

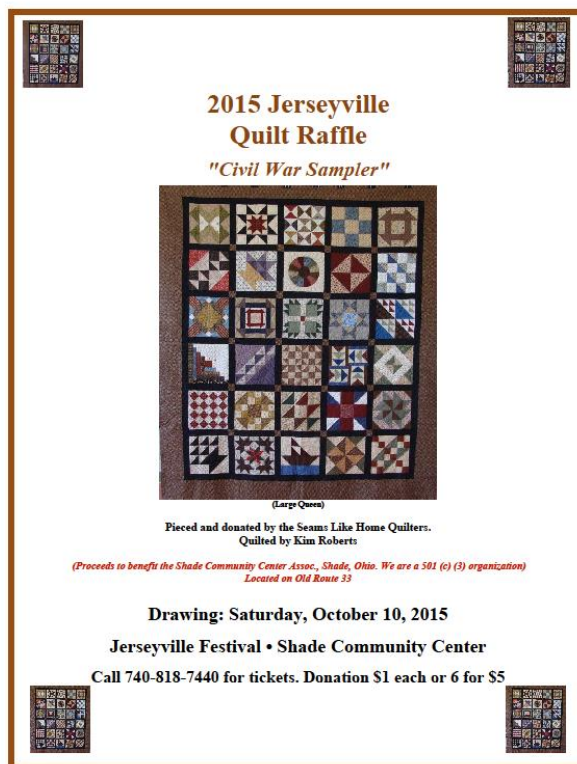

This summer the Shade Community Center was the site of an Intergenerational Summer Feeding Program sponsored by the Corporation for Ohio Appalachian Development (COAD) Senior Program Division. This program met twice each week from June 8 through August 12, and it served children ranging in age from kindergarten through 6th grade. Usually about a dozen children attended, with sixteen being the most on any one day.

Members of the Shade Community Center Association and the Shade Senior Citizens Association who volunteered included Tammy and Jerry Foster, Martha Birt, Karen Jones, Charlotte Benz, Rosemary Vance, Brenda Ruth, and Gail Jordan. Linda Gilden from COAD and three VISTA interns also volunteered, as did Anna and Russell Tenney and Linda Lohse-Smith.

Each day had a theme with programmed activities such as crafts and games, reading time, and lunch with food provided by the Ohio Food Bank. Community members supplemented with local produce and other food items.

The themes included such varied topics as spiders, Johnny Appleseed, flowers, Paul Bunyan, birds, native Americans, Independence Day, seasons and holidays, Revolutionary War, Origami puppets, birthdays, pets, healthy eating, pioneer days, sewing and crafting. Two days included field trips, one to the Richland Volunteer Fire Station in Shade and another to the Fossil Rock Raiders Train Barn. Two days were "movie days". A carnival was held the last day with a variety of games set up in the gym.

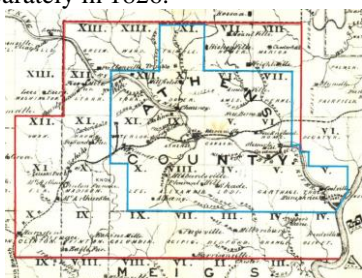
The Changing Borders of Athens County

At the July meeting of the Shade-Lodi History and Genealogy Association, Cyrus Moore showed how Athens County was created and how its borders have changed during its history. He described the surveys completed in the 1780s and the Ohio Company's Purchase in 1787.



Athens County was formed from part of Washington County in 1805. At that time there were only four townships, namely: Ames, Athens, Alexander, and Troy. The inner outline on the map above shows the borders of Athens County as of 1869, when they were essentially the same as they are today. The outer outline on the map above shows the original borders of Athens County. Clearly, the area was much greater then, and parts of what was once Athens County are now located in Meigs, Vinton, Hocking, Morgan, and Washington Counties.

Lodi Township was originally part of Alexander Township. The eastern half of Lodi was included in Carthage when that township was organized in 1819. Lodi was detached and organized separately in 1826.

Alton Story, Champion Motorcyclist

Local motorcycle rider Alton Story made national news in the late 1960s and early 1970s. According to an *Athens Messenger* article in 1968, Alton was among those competing in the American Motorcycle Association's Invitational Race of National Champions, which was telecast on ABC's Wide World of Sports. He was introduced as the third-place amateur in the nation and finished the final race in third place also.



The photo above shows Alton Story on the front page of the September 8, 1970 edition of Cycle News. The caption begins: "Expert Alton Story warms up the Charlie Hawk Maico at Delta Motorsport Park's professional TT..."

This information was gleaned from a treasure trove of clippings about the Story and Saulters (Sauters) families, which were recently donated to the Shade-Lodi History and Genealogy Association by Mrs. Alton Story.

Dixon Family

Kevin King presented "Descendents of Henry Dixon and Elisabeth Lees in Athens and Meigs Counties" at the August meeting of the Shade-Lodi History and Genealogy Association. Kevin is the son of Gloria and Larry King of Pratt's Fork, and Larry's mother was Mabel Dixon.

Mabel's father (Kevin's great grandfather) was Clayton Victor Dixon, who interestingly was Lodi Township mailman from 1904-1934. Clayton's parents were Henry A. Dixon and Rachel Williams. Henry A.'s parents were Samuel Dixon and Mary Bolin. Samuel was born in Belmont County, later moved to Guernsey County, and then purchased land in Alexander Township in 1839. Samuel's parents were Henry Dixon and Elisabeth Lees. This Henry was born in Maryland, then migrated to Ohio. Henry's father Frederick Dixon was Kevin's great-great-great-great-great grandfather!

Kevin elaborated on his ancestor Henry A. Dixon, who was born in Athens County in 1844, lived most of his life in Meigs County, and died in 1940 at age 95. He had the distinction of being the last surviving Civil War veteran of Athens and Meigs Counties. Henry enlisted eight days before his seventeenth birthday and was mustered into the 73rd Ohio Voluntary Infantry. He was in the Battle of Gettysburg and attended the 75th anniversary reunion in 1938. He and his unit were also in many other major engagements, such as the Second Battle of Bull Run, the Chancellorsville Campaign, and General Sherman's famous march to the sea.

I was fortunate to have been a 4-H member for eight years. Actually, I was destined to be in 4-H all along since my Dad was a 4-H adviser, I lived on a dairy farm and my siblings were all 4-H club members. It was a great experience, and I gained in many, many ways.

Farm boys and girls in my day did not have a lot of social options, but 4-H filled the bill for me. An organization for farm youth founded by A.B. Graham in Springfield, Ohio in 1902, the four H's stood for head, heart, hands and health.

Our club, the Bates Boosters, met on a regular basis in members' homes to study a curriculum, enjoy food and engage in yard games like steal the bacon, tag and hide and seek. There were a variety of ages, from 8 to 16 in the group, not too unlike a one room schoolhouse; the younger kids learned from the older kids. We learned things like how to make a rope halter and how to care for and show dairy cattle. We learned how to judge dairy cattle using terms like withers, brisket, dewlap, udder and loin and made field trips to the Athens State Hospital dairy barn to compete with other 4-H clubs in dairy judging contests.

One memorable social event involved an excursion on the Ohio River aboard a paddlewheel river boat, the Avalon, involving many area 4-H clubs. Each summer, the week-long 4-H camp was held at Tar Hollow in the hills of Ross County for members from several counties. I was shy at first and opted not to attend for a couple of years but really enjoyed all of the fun activities once I got up enough courage to go. We swam, did crafts, played softball and ping pong, sang songs, participated in evening vesper services overlooking the lake, hiked and just had a fun time.

The pinnacle for the 4-H year was fair time. Dad would load our 4-H dairy animals into the truck and take them to the Athens County fairgrounds each August. This event lasted the better part of a week and involved feeding, grooming, milking and showing the animals in the show ring for ribbons, trophies and prize money. Of course, I had time to also partake in the other fair activities like the midway rides, kewpie doll contests and grandstand events like the Joie Chitwood Daredevil Show. I especially liked the penny arcade with all of the fun gadgets and machines that issued baseball cards (I wish I still had those.) The final night of the fair featured the colorful and loud fireworks.

4-H was an important part of my life, and I am glad to have had that experience.

SCCA Minutes – July 8, 2015

- Marvin opened the meeting by leading the Pledge of Allegiance.
- The minutes of the June 10 meeting were read by Pat; no corrections were made; Walter made a motion to approve the minutes as read; Norm seconded; motion passed.
- The Corresponding Secretary/Heidi reported she had received two memberships.
- Vice President Report: Peggy distributed the calendar for July and August; attendees suggested corrections and additions. Additions included the Halloween Party scheduled for October 24, and Jerseyville Festival on October 10.
- Treasurer Report: Alex reported that the checking account balance is currently \$10,484.73. For the month of June, revenue exceeded expenses by \$533.89; for the year to date, expenses have exceeded revenue by \$2,352.64.
- Maintenance Committee—Jerry reported that repair work has begun in the gym. The walls have been painted and materials have been ordered for floor tile replacement and sealing. The work on the floor will be scheduled around rental events and the availability of volunteers. Gail reported that all the fire extinguishers have been re-charged. He plans to meet with Tim Hastings, chief of the Richland Area Fire Department, to discuss safety issues in the building. Jerry reported that he is getting quotes for emergency light fixtures; prices so far are approximately \$65 each and he estimates we need 40-42. He will get additional quotes.
- History Group—Brenda reported that at the July 21 meeting the presenter will be Cyrus Moore, talking about the changing borders of Athens County.
- Seniors Association: Manuel and Roberta reported that the group will hold a decorated hat contest at their next meeting on July 9. The Association received annual grant funding from the County, in the amount of \$7,705.
- New Business: Marvin stated that he has been contacted by a representative of American Electric Power, who asked for permission to place two large dumpsters in the Center parking lot during their work to replace poles in the area. The timeframe would be July-November, and the company would pay the Center \$500 for the space. Discussion followed, after which Tammy Foster made a motion to allow the Executive Committee to decide after gathering more information. It was agreed that the dumpsters would have to be temporarily removed for an event in early August, for the Jerseyville Festival on October 10 and for the Halloween Party on October 24. Rhonda seconded the motion and it passed.
- Due to a conflict with the Athens County Fair, it was decided by consensus to hold the August meeting on the 19th rather than the 12th. Gail volunteered to post the date on the marquee sign.
- Marvin and Heidi reported that an unnamed member has requested that the quilt frame be moved from the second floor where it's been stored for some time to a location on the first floor. The only available space would be in the computer room. Gail commented that some items have been removed from the computer room, so there's more space there now. After considerable discussion, Marlesia made a motion that the quilt frame be moved but not assembled until the member who requested the move asks for it to be assembled so she can use it. Heidi seconded the motion and it passed.
- Marvin introduced an amendment to the SCCA Constitution, which would change the number of members attending a meeting required to achieve quorum to conduct business. The Constitution currently requires 10 members plus the officers. The proposed amendment would require ten members, including the officers other than the President, who votes only in the event of a tie. After considerable discussion about the lack of attendance at meetings, Rhonda made a motion to adopt the change; Roberta seconded the motion. A vote was taken, with 9 in favor and 13 opposed. The motion did not pass.
- The Rental Agreement was briefly discussed. Fran made a motion to approve the Agreement as amended; Ray Baker seconded the motion; motion passed. A copy of the Agreement can be obtained from the President or Vice President.
- The Custodial Agreement has been revised and the position is advertised in the July-August newsletter, and will be open until July 15. Marvin reported that three people have indicated interest—Steve Dougan, Karen Radcliff, and Scott Meeks. At the June meeting, members voted to allow the final selection to be made by the Executive Committee and the Maintenance Committee.
- Ray made a motion to adjourn; Robin seconded, and the motion passed.

- Marvin opened the meeting by leading the Pledge of Allegiance.
- There were no corrections or additions to the minutes of the July 8 meeting. Due to low attendance and lack of quorum, no vote was taken to accept the minutes.
- The Corresponding Secretary/Heidi reported she had mailed a get well card and birthday card to two members. She has received four memberships.
- Vice President Report: Peggy distributed the calendar for August and September; attendees suggested corrections and additions.
- Treasurer's Report: Alex reported that he has filed the 2014 tax return after requesting an extension. We owe \$100 to the State of Ohio for the privilege of operating a tax exempt, non-profit organization for another year. For the month of July, revenue exceeded expenses by \$1,089.03; for the year to date, expenses have exceeded revenue by \$6,626.94. Most of the expenses were the result of repairs to the kitchen and the gym floor.
- Maintenance Committee—Jerry reported that repair work has been completed on the gym floor. Jerry extended thanks to helpers George Benz, Dan Morehart, Gail Jordan, Manuel Grueser, Steve Dougan & son, and Ralph Calvert. The total cost of the job was \$4,150. The Alexander School District donated wax stripper and pads; they also gave a permanent loan of a buffing machine. The walls are painted, new baseboard is installed, and new doormats are in place. He has started repair work on the kitchen ceiling and hopes to begin painting the kitchen and cafeteria soon. Gail reported that the boilers passed inspection. Walter has been in discussion with Tim Hastings, Chief of the Richland Area Volunteer Fire Department, about safety issues. They are arranging an inspection of the building, which may include a state inspector.
- History Group—Gail reported that the group met last night; the program for next month will be "Movies Filmed in Ohio".
- Seniors Association: Manuel and Roberta reported that members of the group will take a cruise on the Valley Gem sternwheeler this month. Tammy mentioned that several members participated in the Summer Read and Feed program sponsored by COAD, and the Shade program was considered the best in Athens County. COAD paid \$500 rental for use of the Center.
- Old Business:
 - Janitorial Contract—Steve Dougan cannot take the job due to low pay and other commitments. Marvin and Jerry will talk with the two remaining candidates to find out if they're still interested.
 - AEP Rental—Marv reported and Alex Confirmed that AEP has paid \$500 to park dumpsters on the back edge of the parking area.
- New Business:
 - Fran mentioned that Mark Porter car dealership is closing and has bistro tables in their auction scheduled for August 23. She asked that someone attend the auction to bid on the tables, to be used as extra seating at the Jerseyville Festival.
 - Gail reported that Betty Millko has offered to donate an upright piano and a wheelchair. By consensus, it was agreed that Gail should follow through with arranging for the donations.
 - Robin sent an email to Marvin requesting an advance of \$1,000 "start-up" funding from the Halloween Fund for the upcoming party. Alex agreed to get her a check.
- Ray suggested the meeting be adjourned, and everyone agreed.

Cook's Corner

Pumpkin Bread Pudding



Ingredients

- 1 1/4 cups 2% reduced-fat milk
- 1/2 cup sugar
- 1/2 teaspoon pumpkin-pie spice
- 3 large eggs, lightly beaten
- 1 (15-ounce) can pumpkin
- 4 1/2 cups (1/2-inch) cubed challah or other egg bread (about 8 ounces)
- Cooking spray
- 1/2 cup maple syrup
- 1/4 cup chopped pecans, toasted

Preparation

- Combine first 5 ingredients in a large bowl, stirring well with a whisk.
- Add bread, tossing gently to coat. Spoon mixture into an 8-inch square baking dish coated with cooking spray. Cover with foil; chill 30 minutes or up to 4 hours. Preheat oven to 350°.
- Place dish in a 13 x 9-inch baking pan; add hot water to pan to a depth of 1 inch. Bake, covered, at 350° for 25 minutes. Uncover and bake an additional 10 minutes or until a knife inserted in center comes out clean. Serve each bread pudding piece warm with about 1 tablespoon syrup and 1 1/2 teaspoons pecans.
